Terms and Conditions for IT Vendors



1. Eligibility:

- 1.1. The sign-up process is available only for employees of IT Vendors in the IT industry.
- 1.2. The phrase "IT Vendor" refers to a company that manufactures software or hardware products, which are delivered physically or electronically or via the cloud and are available at a global scale.
- 1.3. Employees must sign up using their official company email address that matches the domain of the IT Vendor's official website.

2. Approval Process:

- 2.1. All sign-ups are subject to an approval process by the ITUpdate content publication team.
- 2.2. The ITUpdate content publication team reserves the right to approve or reject sign-ups at their discretion.
- 2.3. Approval or rejection decisions will be communicated to the user via email.

3. Content Publication:

- 3.1. Once an IT Vendor account is approved, users are permitted to post new content on ITUpdate.
- 3.2. Content posted must be new and relevant to the IT audience.
- 3.3. Approved content types include: Events, Webinars, On-Demand content, Posts, News articles, Press releases, New Product announcements, Promotions, Whitepapers
- 3.4. The ITUpdate content publication team reserves the right to unpublish content that is deemed irrelevant or violates the terms and conditions.

4. Classification and Compliance:

- 4.1. IT Vendors must fit within the IT classifications defined by ITUpdate.
- 4.2. In the event that a signed-up company does not fit within the IT classifications on ITUpdate, the approval for content posting may be denied.

5. Paid products:

- 5.1. Any paid service offered through the ITUpdate platform are subject to payment being made at the commencement of service.
